Type of Hearing: To establish a Municipal Service Benefit Unit (MSBU) for maintenance of retention ponds and streetlighting.

Hearing Required by F. S.# Florida Statute Sections 125.01 (01) (q) and 197.3632. This public hearing may be scheduled any time prior to **May 31, 2025**. **The resolution must be approved by May 31, 2025 to be included on the November 2025 real estate tax bill.**

Notify Abutters: Special Assessments will mail public hearing notices to all of the affected property owners.
