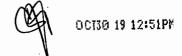

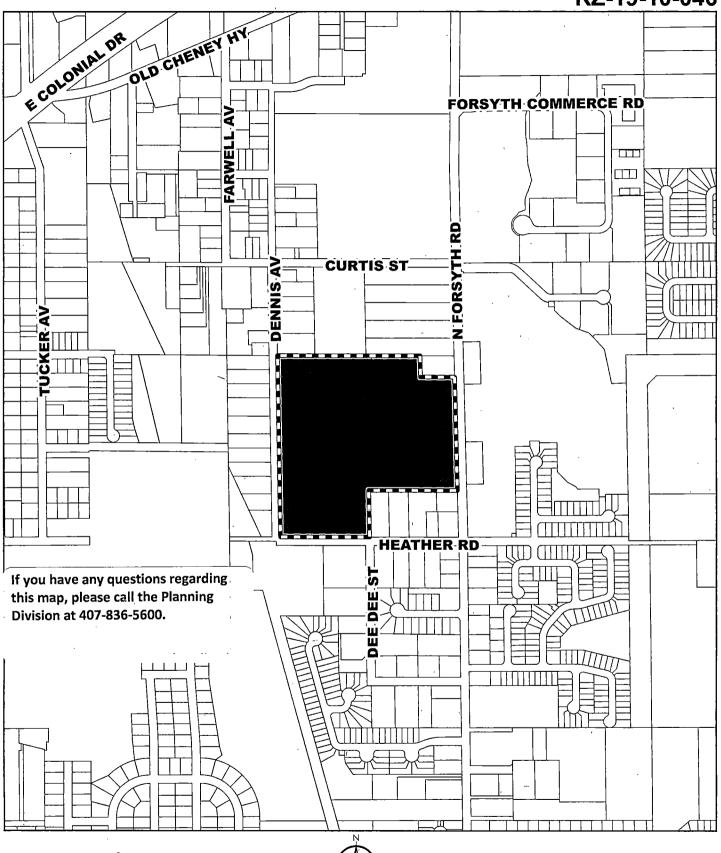
#### **Special Instructions to the Clerk:**
