BACKGROUND:

The School Board of Orange County, Florida ("School Board") has approved a contract with the consulting firm Benesch to review the current school impact fee rate and to facilitate meetings of the School Impact Fee Advisory Group ("Advisory Group"). The Orange County Board of County Commissioners adopted the current school impact fee rate in 2021.

The Advisory Group is required by county ordinance to review the methodology governing how the impact fee is calculated. The Advisory Group includes seven (7) members, including three (3) representatives appointed by the School Board, four (4) representatives appointed by Orange County Board of County Commissioners, one (1) of which will represent the interests of the Greater Orlando Builders Association (GOBA).

The School Board candidates have been contacted by the district and have all three agreed to serve on the Advisory Group.
