Orange County Sheriff's Office Request

The Orange County Sheriff's Office is requesting \$20,000 from the FY 2021 Law Enforcement Trust Fund-State Forfeitures for the following purposes:

#### Contribution:

Children's Safety Village of Central Florida - \$5,000. The Children's Safety Village is one of Orange County's essential resources for life-safety education for young children. Last year staff served over 22,000 community residents with programs and services focused on drowning prevention, pedestrian and bike safety, gun safety, internet safety, and dangerous person awareness.

FBI National Academy Training - \$15,000. Funding contribution for audio/visual training costs associated with the 57th Annual FBI National Academy Associate Training Conference held at the Rosen Shingle Creek Resort from July 7 through 10, 2021.

ACTION REQUESTED: Approval for the Orange County Sheriff's Office to spend \$20,000 from the FY 2021 Law **Enforcement Trust Fund-State Forfeitures for an** eligible contribution to the Children's Safety Village of Central Florida (\$5,000) and FBI National Academy Training (\$15,000).
