ACTION REQUESTED:

Approval to award Invitation for Bids Y23-1056-RM, Sealing Chemicals Line Items 3 and 4, to the low responsive and responsible bidder, Alchatek, LLC, in the estimated contract award amount of \$555,600 for a three-year term. Further request Board authorization for the Procurement Division to renew the contract for two additional one-year terms.

PROCUREMENT:

The contract will provide sealing chemicals used for the maintenance and repair of the Orange County Utilities collection system.

FUNDING:

Funding is available in account number 4420-038-1344-4154.

APPROVALS:

The Field Services Division and Business Development Division concur with this recommendation.

REMARKS:

Four bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Chemline, Inc. was deemed non-responsive for failure to submit required documents. Avanti Material Sales, Ltd. dba Avanti International and Prime Resins, Inc. were deemed non-responsible for failure to meet the reference requirements.

Alchatek, LLC has a satisfactory record of performance, is considered responsible, and has the necessary manpower to perform the contract. Alchatek, LLC is the low responsive responsible bidder for line items 3 and 4. Alchatek, LLC did not submit a bid for line items 1 and 2, therefore are not included in the award. Therefore, recommendation for award is made to Alchatek, LLC.
