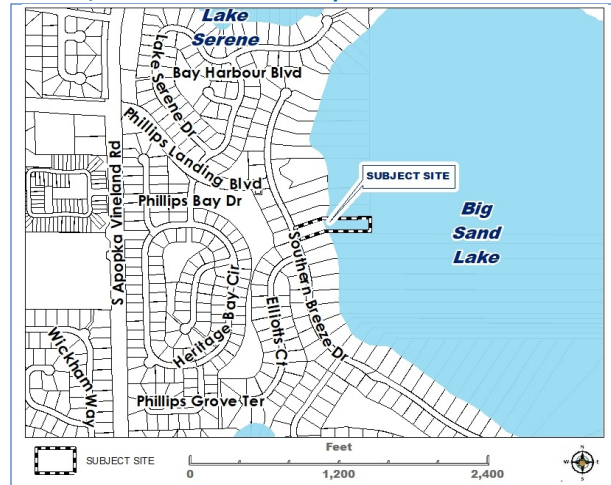

Public Notification Map

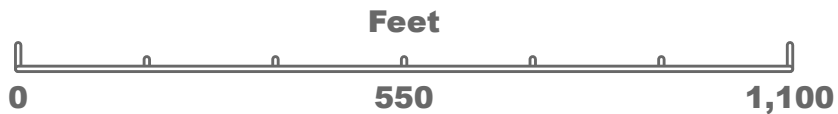

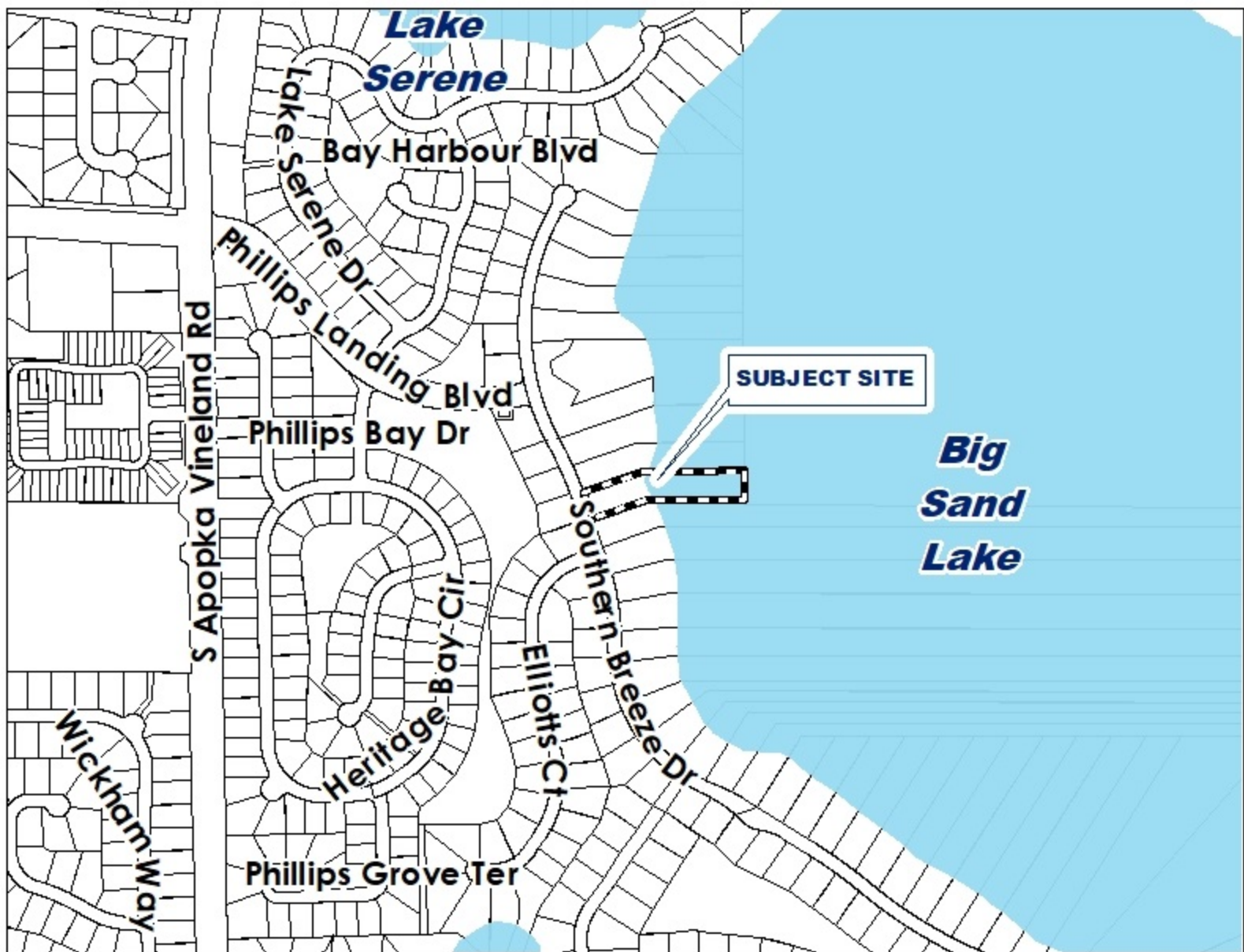

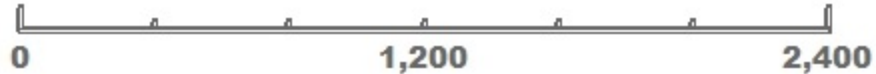
