First Amendment to Art in the Chambers Loan
and Exhibition Agreement with Orlando Museum of Art

Three times a year Orange County borrows art from various institutions and art owners that fit one of the following categories: 1) from major collections in the area, 2) from artists who have lived or worked in Orange County and have a national reputation, or 3) from artists whose work fits a particular theme.

The Orlando Museum of Art has agreed to extend its loan of a selection from its Contemporary American Graphics Collection for exhibition through February 14, 2020. This agreement was approved by the County Attorney's office.

**FIRST AMENDMENT
TO
ART IN THE CHAMBERS LOAN AND EXHIBITION AGREEMENT**
between
ORANGE COUNTY, FLORIDA
and
ORLANDO MUSEUM OF ART

This First Amendment is entered into as of October 19, 2019 by and between **Orange County, Florida**, a charter county and political subdivision of the State of Florida (“County”) and **Orlando Museum of Art** (“OMA”), a non-profit organization.

WITNESSETH

WHEREAS, the Orange County Board of County Commissioners (“BCC”) approved the “Art in the Chambers Loan Agreement” (“Agreement”) between Orange County and the Orlando Museum of Art on May 21, 2019; and

WHEREAS, pursuant to section 2 of the Agreement, the Agreement will expire on October 18, 2019 unless the BCC approves an amendment to extend the term of the Agreement; and

WHEREAS, the BCC now desires to extend the term of the Agreement for an additional four months.

NOW, THEREFORE, in consideration of the foregoing, the parties hereto agree as follows:

1. **Extension of Contract Term.** The Agreement shall remain in effect for a four month term commencing on October 19, 2019 and terminating on February 14, 2020.

2. **Agreement.** All other terms, conditions and obligations of the County and OMA arising from the Agreement shall remain unaltered and in full force and effect.
