## FY 2024-25 Annual Budget Amendments

# Focus of Budget Amendment Adjustments 1. Update cash balances

2. Rebudget unspent funding in prior fiscal year required to complete projects/services

3. Adjust for unanticipated items and cost increases occurring after the budget was adopted



- Total County Budget Adopted was \$7.2 Billion
- Current Budget After Encumbrance Rollovers/Grant Rollovers/Other Grant Budget Adjustments is \$8.2 Billion
- Total Budget After Budget Amendment \$8.5 Billion















 General Fund Ended FY 2023-24 with a \$21.2M Surplus (1.3% of General Fund)
