WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to those certain two portions of a 15 foot wide utility easement located along the north property line of the petitioners residential lot located at 3501 Hill Stream Avenue within the Spring Hollow Subdivision, containing a total of approximately 258 square feet in Orange County, Florida, as described in attachment.




