The Facilities Management Division and the Business Development Division concur with this recommendation.

REMARKS:

Twelve bids were received in response to the Invitation for Bids (IFB). The bids were evaluated for price, responsiveness, and responsibility. Anthony X Gilliam, Florida Greenscapes Management Inc. and Industrial Mowing and Maintenance, LLC were determined to be non-responsive for all lots for failing to meet the experience requirements as outlined in Bidder Qualifications. A.L.G. Landscaping and Concrete Work Inc. was deemed non-responsible based on past unsatisfactory performance.

In accordance with the IFB, award of multiple lots to the same Contractor shall be at the sole discretion of the County. Multiple awards were not recommended for D3 Enviroscapes, LLC due to past performance. Duval Landscape Maintenance, LLC did not meet the requirement for principal place of business.

Staff performed a technical evaluation of the bids and determined that each low bid was reasonable based on, performance and experience. The bidders were determined to be the low responsive and responsible bidders for the items listed and were recommended for award.

D3 Enviroscape, LLC filed a timely protest for lot C. A protest review was held and the Procurement Manager denied the protest.
