Notes:

(1) The Orange County CRA payment involves two parts: the 65% portion of the CRA subject to just the countywide millage, and the 35% portion subject to the countywide millage plus the unincorporated county millage. Computation of the 65% countywide portion: (\$248,772,063/1000)*65%*4.4347 mills=\$717,099; computation of the 35% countywide-plus-unincorporated portion: (\$248,772,063/1000)*35%*(4.4347 mills+1.8043 mills)=\$543,231; sum of the two parts: \$717,099+\$543,231=\$1,260,330 at line E.

(2) The amendment to the Orlando/Orange County Interlocal Agreement--Community Venues, approved by the BCC on Sep 16, 2008, stipulates that the redevelopment agency and the City of Orlando waive their respective authority to receive increment revenues attributable to CRA V; therefore, no payment is required.
