**REMARKS:** 

In 1978, County acquired a Drainage Easement (Easement) for retention pond purposes. The area encumbered by the Easement has since been annexed by the Town of Oakland (Town), and Town has requested that County transfer County's interests in the Easement to Town. The Public Works Department has reviewed the request, determined that the Easement is not needed for County purposes, and agreed to Town's request.

This Assignment of Easement will convey County's interests in the Easement to Town. This Resolution is required by Section 125.38, Florida Statutes, as a condition precedent to this assignment.

## ASSIGNMENT of EASEMENT

THIS ASSIGNMENT of EASEMENT (this "Assignment") is made and entered into by and between ORANGE COUNTY, a charter county and political subdivision of the state of Florida, whose address is P. O. Box 1393, Orlando, Florida 32802-1393, ("Assignor") and TOWN OF OAKLAND, a Florida municipal corporation, whose address is P. O. Box 98, Oakland, Florida, 34760 ("Assignee").

WHEREAS, Assignor is the grantee and current holder of that certain Drainage Easement recorded on September 28, 1978, in Official Records Book 2936, Page 833, and re-recorded on October 4, 1978, in Official Records Book 2938, Page 1199, both of the Public Records of Orange County, Florida (the "Easement"); and

WHEREAS, by virtue of annexation, the lands encumbered by the Easement are now located within the jurisdictional limits of the Town of Oakland; and

WHEREAS, subject to the provisions herein, Assignor desires to assign, and Assignee desires to assume, all of Assignor's rights, titles, duties, obligations, and interests in, to, and under the Easement.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

- 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference.
- 2. <u>Assignment</u>. Assignor hereby assigns and transfers to Assignee, all of the Assignor's rights, titles, duties, obligations, and interests in, to, and under the Easement.
- 3. <u>Assumption</u>. Assignee hereby assumes from Assignor, all of Assignor's duties and obligations under the Easement, including the maintenance of any existing drainage facilities located within the easement area, and Assignee further agrees that, as a condition of this Assignment, Assignee shall assume and abide by all terms and conditions of the Easement.
