ACTION REQUESTED:

Approval to award Invitation for Bids Y19-702-CH, Gatlin Avenue and Kennedy Avenue, and Arrow Road from Gatlin Avenue Intersection Improvements – FPN: 435525-1-58-01 FAN: D518-090-B, to the low responsive and responsible bidder, Southern Development & Construction, Inc., in the estimated contract award amount of \$997,777.

PROCUREMENT:

The project includes widening for the construction of northbound and southbound left turn lanes onto Gatlin Avenue from Kennedy Avenue, westbound and eastbound left turn lanes onto Kennedy Avenue from Gatlin Avenue, and westbound and eastbound left turn lanes onto Arrow Road from Gatlin Avenue. The roadway improvements include full-depth road widening, milling and resurfacing with asphaltic concrete structural course and friction course, asphalt interlayer reinforcement, type B stabilization, soil cement base, clearing and grubbing, excavation, embankment and grading, constructing 4-inch thick concrete sidewalk, pipe handrail and a fence gate, performance turf, and signing and pavement markings. Signalization work includes the relocation of two pedestrian crossing flashing signals on Gatlin Avenue. The project is located in District 4.

FUNDING:

This project will be partially funded by the Florida Department of Transportation (FDOT) in the amount of \$705,841.50. The construction work related to Kennedy Avenue is excluded from federal aid reimbursement, as it is not listed on the Federal Aid System. The bid amount for Kennedy Avenue, as well as the indemnification amount of \$100 will be funded by the County in the amount of \$291,935.50 Funding is available in account numbers: 7529-072-7372-6311 and 1050-062-2100-6311.

APPROVALS:

The Public Works Engineering Division and the Highway Construction Division concur with this recommendation.

REMARKS:

Three bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. The solicitation was conducted in accordance with FDOT's competitive procurement for construction services with the Local Agency Program Agreement. The County's M/WBE program is not applicable for this procurement.

Staff evaluated the bids and determined that the low bid is reasonable. References provided were satisfactory for this type of work and Southern Development & Construction, Inc. has been determined to be responsible. FDOT concurs with the recommendation of award to Southern Development & Construction, Inc. Therefore, award is recommended to Southern Development & Construction, Inc.
