Adoption of Future Land Use Map Amendment SS-23-07-039, Ordinance and Concurrent Rezoning Request RZ-23-08-069, Jordan S. Strasberg

a. Amendment SS-23-07-039

Consideration: To change the Future Land Use designation from Low Density Residential (LDR) to Low-Medium Density Residential (LMDR); pursuant to Part II, Chapter 163, Florida Statutes and Orange County Code Chapter 30

Location: District 2; property located at 5308 Davisson Avenue; generally located on the west side of Davisson Avenue, approximately 65 feet north of Van Ness Street (legal property description on file)

Consideration: AN ORDINANCE PERTAINING TO COMPREHENSIVE PLANNING IN ORANGE COUNTY, FLORIDA; AMENDING THE ORANGE COUNTY COMPREHENSIVE PLAN, COMMONLY KNOWN AS THE "2010-2030 COMPREHENSIVE PLAN," AS AMENDED, BY ADOPTING SMALL-SCALE DEVELOPMENT AMENDMENTS PURSUANT TO SECTION 163.3187, FLORIDA STATUTES; AND PROVIDING EFFECTIVE DATES.

C. RZ-23-08-069

Consideration: To change the zoning district from R-2 (Residential District) to R-2 Restricted (Residential District) to allow for a duplex; pursuant to Part II, Chapter 163, Florida Statutes and Orange County Code Chapter 30

Location District 2; property located at 5308 Davisson Avenue; generally located on the west side of Davisson Avenue, approximately 65 feet north of Van Ness Street; Orange County, Florida (legal property description on file in Planning Division)

A motion was made by Commissioner Moore, seconded by Commissioner Gomez Cordero, to make a finding of consistency with the Comprehensive Plan; further, adopt Amendment SS-23-07-039, Low-Medium Density Residential (LMDR) Future Land Use Designation; further, adopt the associated Ordinance 2023-38; and further, approve the rezoning request Case # RZ-23-08-069 from R-2 (Residential District) to R-2 Restricted (Residential District) subject to the one (1) restriction listed under the Planning and Zoning Commission in the Staff Report dated September 19, 2023.
