RECOMMENDATION:

Selection of one firm and two ranked alternates to provide Professional Transportation Planning and Engineering Services for the North East Orange County Areawide Transportation Study, Request for Proposals Y20-827-CH, from the following firms listed alphabetically. Further, request the Board authorize negotiation and execution of a contract by the Procurement Division provided that the contract does not exceed the budget amount of \$650,000.

- HDR Engineering, Inc.
- Vanasse, Hangen & Brustlin, Inc.
- WSP USA, Inc.

The Procurement Committee evaluated the proposals on July 29, 2020. Commissioner Victoria P. Siplin was assigned to the Procurement Committee.

PURPOSE:

The Consultant shall assist the County by providing professional transportation planning and engineering services for the North East Orange County Areawide Transportation Study. The study is a long range transportation plan, which shall address the increased mobility demands in East Orange County. The main objective is to identify and analyze potential transportation projects that would improve network connectivity and provide relief to constrained corridors. The study shall develop a prioritized list of regional roadway improvements as well as intersection improvements, transit, pedestrian, and bicycle enhancements supported and authorized by a robust series of public engagement meetings and hearings. In the short term, the plan will serve as a guide for capital improvement expenditures and in the long term as a basis for coordination between future land use and the area's transportation needs. The study limits encompass the region

north of Colonial Drive (SR 50), south of Orange/Seminole County line, east of Alafaya Trail and west of Chuluota Road. The project is located in District 5.

Three proposals were received in response to the Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP. The Consensus scores from the Procurement Committee are attached.
