RECOMMENDATION:

Selection of Ardaman & Associates, Inc., Terracon Consultants, Inc., and Universal Engineering Sciences, LLC to provide Continuing Professional Services for Geotechnical and Construction Materials Testing, Request for Proposals Y24-903-MB.

Further request Board authorization for negotiation and execution of the final contracts by the Procurement Division to establish hourly rates for future requirements for an initial one-year term with two one-year renewals.

The Procurement Committee evaluated the proposals on April 10, 2024. Commissioner Mayra Uribe was assigned to the Procurement Committee.

PROCUREMENT:

The contracts will provide continuing geotechnical engineering and materials testing services for the construction/renovation of buildings and/or storm water and/or wastewater relating to culverts, asphalt, roadways, parking area, rigid and flexible pavement, sidewalks, bridges, reinforced concrete structural steel, underground utilities, and roofing assemblies.

DISCUSSION:

Five proposals were received in response to this Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP. The proposals for Colliers Engineering & Design, Inc. and Engineering Consulting Services, LTD. Corporation scored too low for board consideration.
