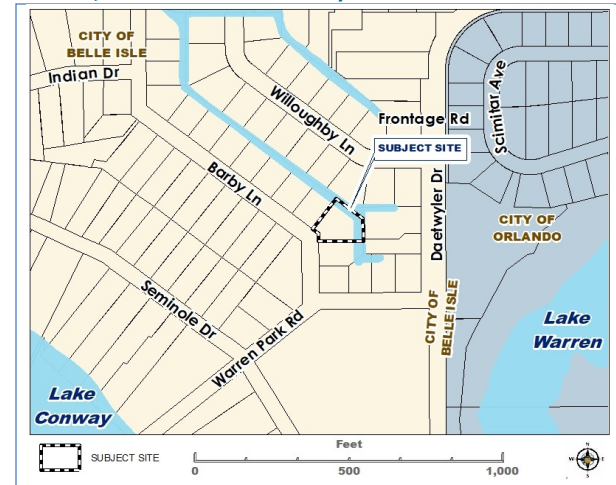

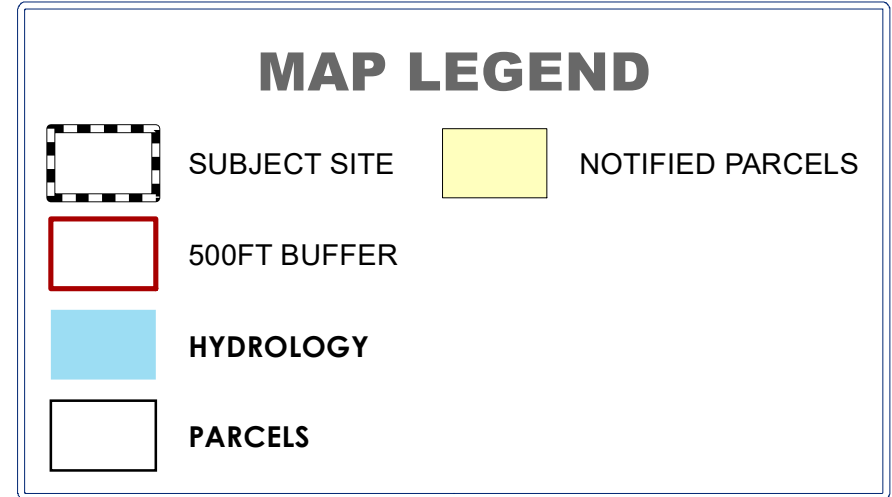

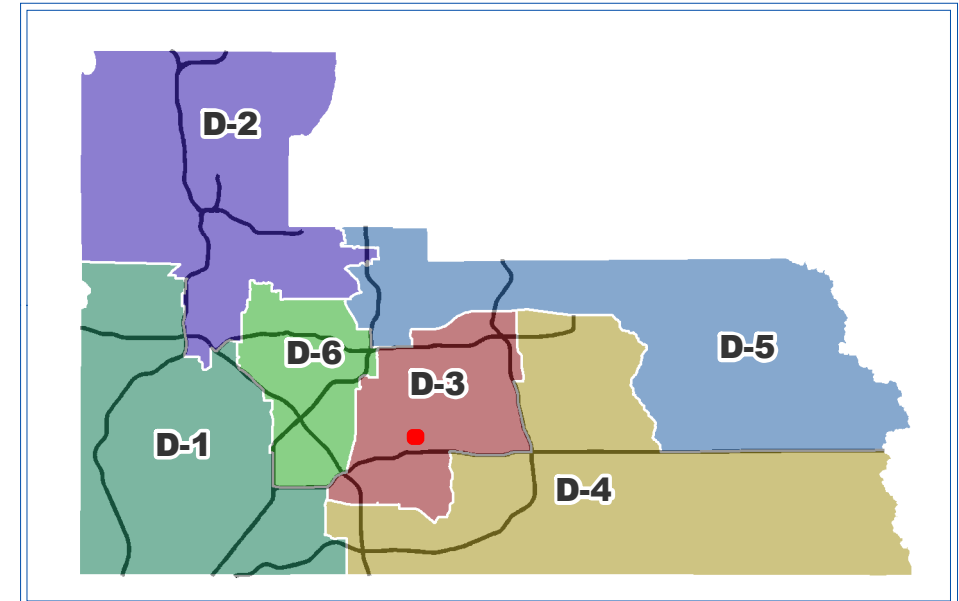

Public Notification Map

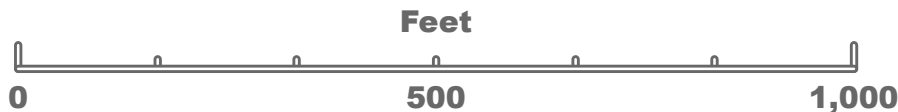
