Consideration: Request to rezone 0.311-gross acre from C-2 (General Commercial District) to C-3 Restricted (Wholesale Commercial District) to allow outdoor storage and overnight parking of semi-truck head and dump truck (two dual rear-wheeled vehicles). A variance from Orange County Code to allow 60 foot lot width in lieu of 100 feet is requested.
