On September 21, 2023, the Board approved an estimated budget for the Oaks Specialized Community Supervision Program in the amount of \$866,127. The Florida Department of Juvenile Justice (DJJ) has awarded year nine of the contract in the amount of \$678,772, which represents a decrease in the amount of \$187,355. The grant fiscal budget period is from July 1, 2024 through June 30, 2025.

With this funding, Orange County will continue to provide specialized community supervision to youth, between the ages of 10 - 17, that have shown to be moderate to high risk of continued involvement with the DJJ in Circuit 9.

Therefore, in accordance with Section 129.06(2)(d), Florida Statutes, it is recommended that the following accounts be adjusted by the amounts shown.
