#### **ACTION REQUESTED:**

Approval to award Invitation for Bids Y18-1104-AH, Burial and Cremation Services, to the low responsive and responsible bidder, Waldon Professional Funeral & Cremation Services, LLC, for a 3-year term in the estimated award amount of \$707,940. Further request authorization for Procurement Division to renew the contract for two additional 1-year terms.

#### **PROCUREMENT:**

To provide burial and cremation services for persons that expire in Orange County and are unclaimed, lack the financial resources, or have no relatives willing or able to provide for the burial and cremation.

#### **FUNDING**:

Funds are available in account number 0001-060-2457-3197.

### APPROVALS:

The Health Services Department and Business Development Division concur with this recommendation.

#### REMARKS:

Three bids were received and evaluated for responsiveness and responsibility. The bid for Waldon Professional Funeral & Cremation Services, LLC is the lowest responsive and responsible bidder. Compass Pointe Cremation Services, LLC was deemed non-responsible as their references did not demonstrate the required experience.

Protests were filed by Gail & Wynn's Mortuary, Inc. and Compass Pointe Cremation Services, LLC. Protest reviews were conducted by the Procurement Manager, who denied both protests. Both firms appealed and a protest hearing was conducted.

The protest committee consisted of Eric Gassman, John Goodrich, Scott Shevenell (non-voting), and Sheena Ferguson. The Protest Committee unanimously denied both appeals and confirmed the recommendation to award to Waldon Professional Funeral & Cremation Services, LLC.
