Consideration: This request is to remove previously permitted 50' lots within Phase 2 and replace with 60' lots. Phase 2 will be divided into proposed Phases 2 and 3. In addition, a waiver from Orange County Code Section 38-1387.1(a)(10) is requested to allow a 14' building separation between townhomes in lieu of 20'; pursuant to Orange County Code, 34, Article III, Section 34-69 and Chapter 30, Article III, Section 30-89.
