RECOMMENDATION:

Selection of CDM Smith, Inc. to provide Project Management, Construction Engineering and Inspection (CEI) Services for Kirkman Road Extension Project, Request for Proposals Y20-816-CH. Further, request the Board authorize negotiation and execution of a contract by the Procurement Division provided that the contract does not exceed the budget of \$900,000.

The Procurement Committee evaluated the proposals on June 10, 2020. Commissioner Emily Bonilla was assigned to the Procurement Committee.

PURPOSE:

The Consultant shall assist the County by providing project management and CEI services for the Kirkman Road extension project. The project is located in District 6.

The services to be performed include, but are not limited to:

- Pre-construction services include plan review, public information services, and establishment of document control systems and payment procedures.
- Project management and CEI services include reviewing and approving of material submittals, progress and utility coordination meetings, oversight of document controls, development of systems for avoidance and resolution of claims/disputes, and public information services.
- Inspection services consist of the observation and documentation of the Contractor's work and compiling reports and diaries as needed to track production and activities.
- Post-construction services include reviewing punch lists, management of project closeout requirements, monitoring closure of environmental resource permits and other permits as applicable, and issuance of final certifications.

 Contract administration services include audit of pay applications, document control, tracking of eligible and non-eligible costs for reimbursements, and maintenance of project cost reports.

GAI Consultants, Inc: Declined to propose due to high workload and future business opportunities.

Tierra, Inc: Declined to propose due to high workload and future business opportunities.
