ACTION REQUESTED:

Approval to award Invitation for Bids, Y18-788-RC, Orange County Code Enforcement Office Renovations – Cassidy Building to the low responsive and responsible bidder, Johnson-Laux Construction, LLC in the total contract award amount of \$1,539,000.

PROCUREMENT:

The scope of work consists of the renovation of the second floor for the Orange County Code Enforcement offices at the Cassidy Building. The renovation includes the replacement of restrooms, offices, conference room, and open areas. The mechanical, plumbing, and technology will be updated to accommodate the new work and new ceiling. The electrical work will include replacement of a generator, transformers, transfer switchgears and electrical panels on the entire building. The project is located in District 6.

FUNDING:

Funding is available in account number 1023-068-3222-621 and 1023-043-0263-6210.

References provided were satisfactory for this type of work and Johnson-Laux Construction, LLC, has been determined to be responsible. Therefore, award is recommended to Johnson-Laux Construction, LLC.

The Business Development Division evaluated the 4 lowest bids of the 8 bids submitted for this project and found that the apparent low bidder Johnson-Laux Construction, LLC did not achieve good faith effort documentation. While the low bidder reported \$492,756 in MWBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the MWBE participation could not be confirmed.

The second low bid submitted by Oelrich Construction, Inc. did not achieve good faith effort documentation. While the low bidder reported \$13,000 in MWBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the MWBE participation could not be confirmed.

The third low bid submitted by Mar-Con Construction, LLC dba Marbek Construction Co. did not achieve good faith effort documentation. While the low bidder reported \$33,992 in MWBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the MWBE participation could not be confirmed.

The fourth low bid submitted by Mulligan Constructors. Inc. did not achieve good faith effort documentation and reported 0% MWBE participation in their bid.

None of the bids met the MWBE sliding scale range criteria to be awarded this contract over the low bidder.
