Subject: Award of Invitation for Bids Y18-765-EB, Lake Jennie Jewel Baffle Box Project

ACTION REQUESTED:

Approval to award Invitation for Bids Y18-765-EB, Lake Jennie Jewel Baffle Box Project, to the low responsive, responsible bidder, Uribe Site Development, Inc. in the total contract award amount of \$278,250.

PROCUREMENT:

To install a Nutrient Separating Baffle Box (NSBB) with an up-flow filter chamber filled with Biosorption Activated Media at Lake Jennie Jewel. The project also includes a porous paving system installed in the direct vicinity of the NSBB to protect the sod from damage caused by maintenance vehicles. The existing bubble-up outfall structure will be removed and replaced with a winged end-wall. Riprap will be installed at the outfall for energy dissipation and erosion control. The downstream channel banks will be lined with a permanent erosion control matting to prevent erosion of the banks. The project is located in District 3.

FUNDING:

Funding in the amount of \$119,000 is available from a grant by St. John's River Water Management District and the amount of \$159,250 is available in account number 1023-021-0191-3197.

APPROVALS:

The Highway Construction Division and Business Development Division concur with this recommendation.

REMARKS:

Seven bids were received in response to this Invitation for Bids. Uribe Site Development, Inc. has been determined to be the low responsive bidder. Uribe Site Development, Inc. has satisfactory record of performance and has been determined responsible. Therefore, award is recommended to Uribe Site Development, Inc.
