You are invited to attend and be heard regarding the following proposed ordinance:

AN ORDINANCE RELATING TO RESIDENTIAL TENANCIES IN INCORPORATED AND UNINCORPORATED AREAS OF ORANGE COUNTY; AMENDING CHAPTER 25 OF THE ORANGE COUNTY CODE OF ORDINANCES ("CODE"); CREATING ARTICLE XIII, SECTIONS 25-370 THROUGH 25-449 OF THE CODE; REQUIRING A WRITTEN NOTIFICATION PERIOD FOR THE TERMINATION OF CERTAIN RESIDENTIAL TENANCIES; REQUIRING A WRITTEN NOTIFICATION PERIOD FOR RENT INCREASES FOR CERTAIN RESIDENTIAL TENANCIES; PROVIDING FOR ENFORCEMENT AND PENALTIES FOR VIOLATION; AMENDING SECTION 11-62 OF THE CODE; PROVIDING FOR REPEAL OF LAWS IN CONFLICT; AND PROVIDING FOR FILING OF ORDINANCE AND EFFECTIVE DATE.
