I am pleased to present the managerial appointment of Mr. Jason Reynolds to the Neighborhood Services Division. He is an outstanding member of the Planning, Environmental and Development Services Department and will bring unique skills and experience to his role as Manager. Mr. Reynolds currently serves as the Administrator for the Neighborhood Services Division.

Jason began his career in 2005, as a Graduate Intern/Assistant Project Manager for the West Palm Beach Housing Authority. In 2007, he was a Planning Consultant and Facilities Planning Specialist for the Planning Services Division for the Osceola County School District. He also represented the School District's interest as a member of the City of St. Cloud's Planning Commission.

In 2009, Jason was hired by Orange County as a Senior Planner. In 2017, he was promoted to Neighborhood Services Administrator. He has managed the economic and community grant programs, supported Orange County's neighborhood outreach programs, and worked with elected officials to implement projects and identify solutions that address neighborhood problems. He has also established partnerships with county neighborhoods and other local government jurisdictions.

In 2015, he became certified with American Institute of Certified Planners (AICP). Mr. Reynolds is also actively involved in several community organizations such as the Professional Advisory Council for the University of Florida, Orlando City Foundation board member, and a mentor at Jones High School.

Mr. Reynolds received his bachelor's degree in criminology and a master's degree in urban and regional planning from the University of Florida. He has considerable public service experience and a solid understanding of the operations within the division.
