Prevention Assemblies

ACTION REQUESTED:

Approval to award Invitation for Bids Y24-128-RM, Testing and Repair of Backflow Prevention Assemblies, to the low responsive and responsible bidders, Nils Humberg Enterprises, LLC dba Ace Flow Control, in the estimated contract award amount of \$372,375 for a one-year term and Aaron's Backflow Services, Inc., in the estimated contract award amount of \$432,000 for a one-year term. Further request Board authorization for the Procurement Division to renew the contracts for four additional one-year terms.

PROCUREMENT:

These contracts will provide physical testing and repair of backflow prevention assemblies on properties of Orange County Utilities (OCU) customers, including residential irrigation and potable water services that are required to have backflow prevention devices or assemblies. It also includes making the necessary repairs and re-testing the device to obtain acceptable test results and reporting the results of testing including the needed repairs to OCU's Cross Connection section.

FUNDING:

Funding is available in account number 4420-038-1326-3840.

APPROVALS:

The Water Operations Division and Business Development Division concur with this recommendation.

REMARKS:

Seven bids were received in response to this Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. National Metering Services, Inc. was deemed non-responsible for failure to meet the reference requirements. Ackerman Plumbing, Inc. and Summit Fire & Security, LLC were deemed non-responsive for failure to submit copies of required certification documents. Nils Humberg Enterprises, LLC dba Ace Flow Control and Aaron's
