ACTION REQUESTED:

Approval of commercial refuse license for Affinity Waste Solutions, LLC to provide solid waste hauling services to commercial generators in Orange County for a five-year term. All Districts. (Solid Waste Division)

PROJECT: N/A

PURPOSE: The Solid Waste Division has received a commercial refuse license application from Affinity Waste Solutions, LLC, to provide solid waste hauling services to multi-family, construction and demolition, and other commercial generators in Orange County.

Section 32-178 of the Orange County Code requires that the applicant

- Purchase and maintain required insurance
- Demonstrate the service capability of vehicles and equipment
