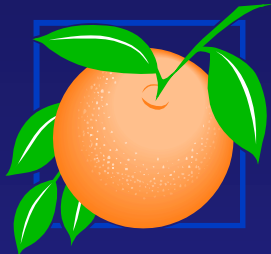

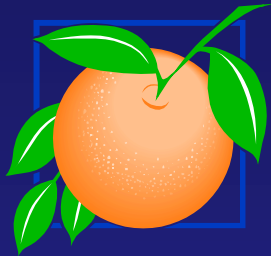

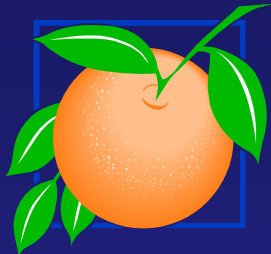
Library Board of Trustees

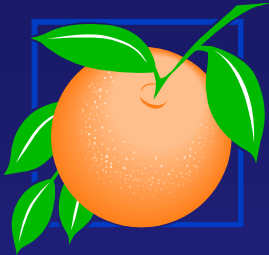
- **Five members appointed by the Governing Board:**

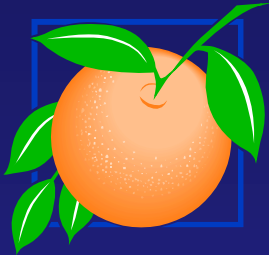

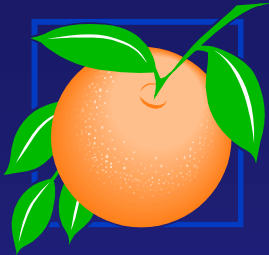

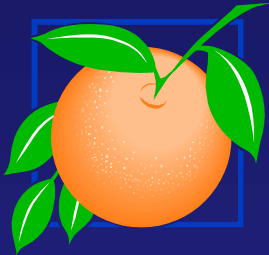
Code Enforcement Board

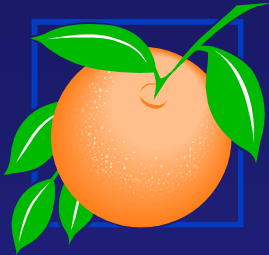
- **Seven members appointed on the basis of experience or interest in the fields of zoning and building control**
