The Department of Homeland Security, through the Federal Emergency Management Agency, awarded Fiscal Year 2019 Assistance to Firefighters Grant EMW-2019-FG-05593 to the Orange County Fire Rescue Department in the amount of \$696,595.95 with \$69,659.59 matching non-federal funds for a total amount of \$766,255.54.

These funds will be used to procure 1,124 Firefighter Escape Systems and train firefighters in their use. This program will enhance personnel safety by equipping and training firefighters to perform emergency egress from the upper floors of a structure.

**Article 1 Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**
