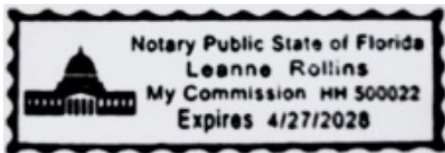

# PUBLIC NOTICE Avalon Road (C.R. 545) Improvements Public Hearing

Tuesday, May 5, 2026, 9:00 a.m.

Avalon Road (C.R. 545) is planned to be widened from two lanes to four lanes between U.S. 192 and Hartzog Road, a distance of approximately 1.6 miles. The project includes a sidewalk on the east side of the roadway and a multiuse path on the west side. Additional improvements include access management, improved drainage, improved geometry, roadway lighting, and landscaping.

The purpose of the project is to reduce congestion and improve mobility along this section of Avalon Road. Improvements will also enhance safety and support the County's vision for corridors to serve as multi-modal facilities that serve motorists, pedestrians, and bicyclists.
