Subrecipient Agreements
Community Development Block Grant 2020-2021

On August 11, 2020, the Board approved Orange County's 2020-2021 Action Plan for housing and community development activities under the Community Development Block Grant (CDBG) program. The Action Plan utilizes some of the CDBG funds to support capital improvements related to rehabilitation of public facilities that provide services and/or affordable housing to low to moderate-income individuals and families, as well as chronically homeless persons and individuals with disabilities.

Subrecipient Agreements must be executed with the non-profit agencies to implement the projects in the 2020-2021 Action Plan. The agreements have been reviewed by the County Attorney's Office as to form. A list of the agreements and funding amounts awarded is attached.
