ACTION REQUESTED:

Approval of Amendment No. 4, Contract Y23-2501, Ending the HIV Epidemic (EHE) Short Term Housing Assistance and Case Management Services, with Miracle of Love, Inc., in the amount of \$773,913.04, for a revised estimated contract amount of \$1,200,000.

PROCUREMENT:

This amendment adds funding for short term housing assistance and case management services to eligible clients located in Orange County for the performance period of March 1, 2024, through February 28, 2025.
