Further, request the Board to authorize the Procurement Division to negotiate and award a contract provided that it does not exceed the budget of \$700,290.

PURPOSE:

The purpose of this contract is to select a firm to provide design services for Orange County Traffic Signal Cabinets Upgrades. This project is located throughout Orange County, Florida.

DISCUSSION:

The design services will address needed upgrades for existing sub-standard traffic signal cabinets to latest standards and install new uninterruptable power source cabinets and communication switches. This will allow future interface with connected and autonomous vehicles as they become more prevalent.

- 1. Traffic Signal and Interconnect Design
- 2. Maintenance of Traffic Design
- 3. Signalization Plans

Orange County will receive federal funding through the Florida Department of Transportation (FDOT) for the services solicited in the Request for Proposal. Pursuant to the funding requirement of the FDOT's grant, disadvantage business enterprise (DBE) utilization shall be in compliance with applicable laws and regulations. FDOT has established a DBE program in accordance with such federal laws and regulations.

Accordingly, Orange County's M/WBE ordinance and program do not apply to this solicitation. FDOT's DBE goal set for this project is 10.65%.
