Approval to award Invitation for Bids Y22-786-ZR, South Water Reclamation Facility (SWRF) Programmable Logic Controllers Replacement, to the low responsive and responsible bidder, Florida Design Contractors, LLC in the total contract award amount of \$4,382,677.78.

Work under this contract includes the improvements to the SWRF existing control system including the replacement to the existing Programmable Logic Controllers. The project is located in District 6.
