ACTION REQUESTED:

Approval to award Invitation for Bids, Y18-793-TA, Force Main East Area Package 3, to the low responsive and responsible bidder, RMS Constructors Group, LLC in the estimated contract award amount of \$2,155,112.41.

PROCUREMENT:

The work includes the replacement of 3,450 linear feet of 6-inch force main, 1,560 linear feet of 8-inch force main, and 750 linear feet of 12-inch force main at four locations throughout eastern Orange County. The installation of the forcemain will extend the useful life of the system and provide a more reliable pressurized wastewater system. This project is located in District 4.

FUNDING:

Funding is available in account number 4420-038-1539-6345.

<u>APPROVALS:</u>

The Engineering Division and the Business Development Division concur with this recommendation.

REMARKS:

Four bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Valencia Construction Group, Inc. was deemed non-responsible as their references did not meet the minimum requirements. RMS Constructors Group, LLC has a satisfactory record of performance and is considered responsible. Therefore, award is recommended to RMS Constructors Group, LLC.

The Business Development Division evaluated the 3 bids submitted for this project and found the apparent low bidder RMS Constructors Group, LLC did not achieve good faith effort documentation and reported 24.51% MWBE participation in their bid. Please note the following certified MWBE participation:

The second low bid submitted by Prime Construction Group, Inc. achieved good faith effort documentation. While the third low bidder reported \$291,407.50 in MWBE participation, they did not specify the work to be performed on attachment C-2. Therefore, the MWBE participation could not be confirmed.

The third low bid submitted by RCS Construction Company, Inc. did not achieve good faith effort documentation and reported 14.27% MWBE participation in their bid.

None of the bids were met the MWBE sliding scale range criteria to be awarded this contract over the low bidder.
