First Amendment to Agreement by and between Orange County, Golden

Oak Development, LLC for Traffic Law Enforcement on Private Roads

Section 316.006, Florida Statutes allows counties to exercise traffic law enforcement over private roads if the owner of the private road enters into a written agreement with the County. Prior to entering into such an agreement, the Sheriff's Office must be consulted. Such agreements cannot go into effect until the beginning of the County's fiscal year, unless the Sheriff waives such requirement in writing.

Golden Oak Development, LLC has requested such an agreement for the private roads located within the gated community of Golden Oak Phase 4 and 5. This Amendment is to expand the service area to include the final phases of the community as indicated therein. The Sheriff's Office has been involved with the negotiation of the contract and has executed a waiver that will allow this agreement to go into effect upon Board approval.

No relationship disclosure form is provided because this is neither a development-related nor a procurement-related item. No specific project expenditure report is provided because this is a ministerial item.

This Agreement has been reviewed by the County Attorney's Office and has been found acceptable.

FIRST AMENDMENT TO AGREEMENT FOR TRAFFIC LAW ENFORCEMENT ON PRIVATE ROADS

This First Amendment to Agreement for Traffic Law Enforcement on Private Roads (this "First Amendment") is entered into by and between Orange County, Florida (hereinafter "County"), a charter county and political subdivision of the State of Florida, and Golden Oak Development, LLC (f/k/a Golden Oak Estates, LLC) (hereinafter "Owner"), a Florida limited liability company.

WITNESSETH:

WHEREAS, County and the Owner entered into an Agreement for Traffic Law Enforcement on Private Roads, last executed on June 29, 2010 (the "Agreement"), whereby Owner contracted with County to provide, through the Orange County Sheriff's Office, enforcement of the traffic laws of the State of Florida on private roads located in the gated community of Golden Oak (f/k/a Northeast Resort Parcel) (collectively referred to as "Private Roads"); and

WHEREAS, Owner has conveyed ownership of certain Private Roads to Golden Oak Non-Residential Association, Inc. (the "Golden Oak NRA") and in connection therewith has partially assigned the Agreement to Golden Oak NRA pursuant to: (a) a Partial Assignment and Assumption of Agreement for Traffic Law Enforcement on Private Roads, dated January 19, 2011; (b) a Partial Assignment and Assumption of Agreement for Traffic Law Enforcement on Private Roads, dated March 4, 2011; and (c) a Partial Assignment and Assumption of Agreement for Traffic Law Enforcement on Private Roads, dated March 15, 2011; and

WHEREAS, Owner, as contemplated by the Agreement, has developed Phase 4 of the Golden Oak development ("Phase 4") and is currently developing Phase 5 of the Golden Oak development ("Phase 5"); and

WHEREAS, Owner has completed construction of the Private Roads located within Phase 4 (collectively "Existing Private Roads"), as more particularly described in <u>Exhibit "A"</u> attached hereto and incorporated herein by this reference; and

WHEREAS, Owner plans to construct Private Roads within Phase 5 (collectively "Future Private Roads"), which shall be located on land owned by the Owner in fee simple more particularly described in Exhibit "A"; and

WHEREAS, portions of the Existing Private Roads the Future Private Roads are or will be located on bridges that cross a drainage canal commonly known as the C-1 canal in Phase 4 (the "Phase 4 Canal Property"), and Bonnet Creek in Phase 5 (the "Phase 5 Canal Property") (collectively, the "Phase 4 and 5 Canal Property"); and


- WHEREAS, the Phase 4 and 5 Canal Property is owned in fee simple by the Reedy Creek Improvement District, a public corporation and public body corporate and politic of the State of Florida ("RCID"), and is more specifically described in **Exhibit "A-1"** attached hereto and incorporated herein; and
- WHEREAS, RCID granted a non-exclusive easement to the Owner on, over and across the Phase 4 Canal Property for, among other things, the Owner's installation, maintenance, repair and replacement of a bridge structure and ancillary improvements for that portion of the Private Roads crossing the Phase 4 Canal Property, which easement was recorded on September 19, 2016 in Official Records Document #20160492540 of the Public Records of Orange County, Florida; and
- WHEREAS, RCID granted a non-exclusive easement to the Owner on, over and across the Phase 5 Canal Property for, among other things, the Owner's installation, maintenance, repair and replacement of a bridge structure and ancillary improvements for that portion of the Private Roads crossing the Phase 5 Canal Property, which easement was recorded in the Public Records of Orange County, Florida; and
- WHEREAS, the Owner is requesting that the County, through the Orange County Sheriff's Office, enforce traffic laws upon the Existing Private Roads and the Future Private Roads, in addition to those roads identified in the Agreement (collectively referred to as "Private Roads"); and
- WHEREAS, the Sheriff has agreed to exercise traffic law enforcement upon the Private Roads, as more specifically identified in the Agreement and this First Amendment; and
- WHEREAS, in accordance with Section 316.006(3)(b)(2), Florida Statutes, the Sheriff has agreed to waive the October 1 requirement, as evidenced by **Exhibit "B"**, attached hereto and incorporated by reference; and
- WHEREAS, Owner desires to amend the Agreement to add and subject the Existing Private Roads located within Phase 4 and Future Private Roads within Phase 5 to the terms and conditions of the Agreement; and
- WHEREAS, the Parties agree that all other terms and conditions set forth in the Agreement shall remain valid and in effect unless specifically amended or otherwise modified under this First Amendment.
- **NOW, THEREFORE**, in consideration of the covenants and conditions herein, the County and Owner hereby agree as follows:
- 1. **Recitals and Defined Terms.** The above recitals are true and correct, and are incorporated herein by reference and form a material part of this First Amendment. Capitalized terms not otherwise defined herein shall have the same meaning ascribed to such terms in the Agreement unless the context requires otherwise

2. Land and Private Roads.

- A. Exhibit "A" of the Agreement is hereby amended to include the land more specifically described in **Exhibit "A"** attached hereto and incorporated herein.
- B. Exhibit "A-1" of the Agreement is hereby amended to include the land more specifically described in **Exhibit "A-1"** attached hereto and incorporated herein.
- 3. **Conflicts.** To the extent there is a conflict or inconsistency between the terms and provisions of this First Amendment and the Agreement, the terms and provisions of this First Amendment shall control.
- 4. Waiver and Modification. This First Amendment may not be waived, modified or changed except in writing and executed by both parties.
- 5. Confirmation of Agreement. Except as modified by the terms of this First Amendment, the Agreement is hereby ratified and confirmed.


