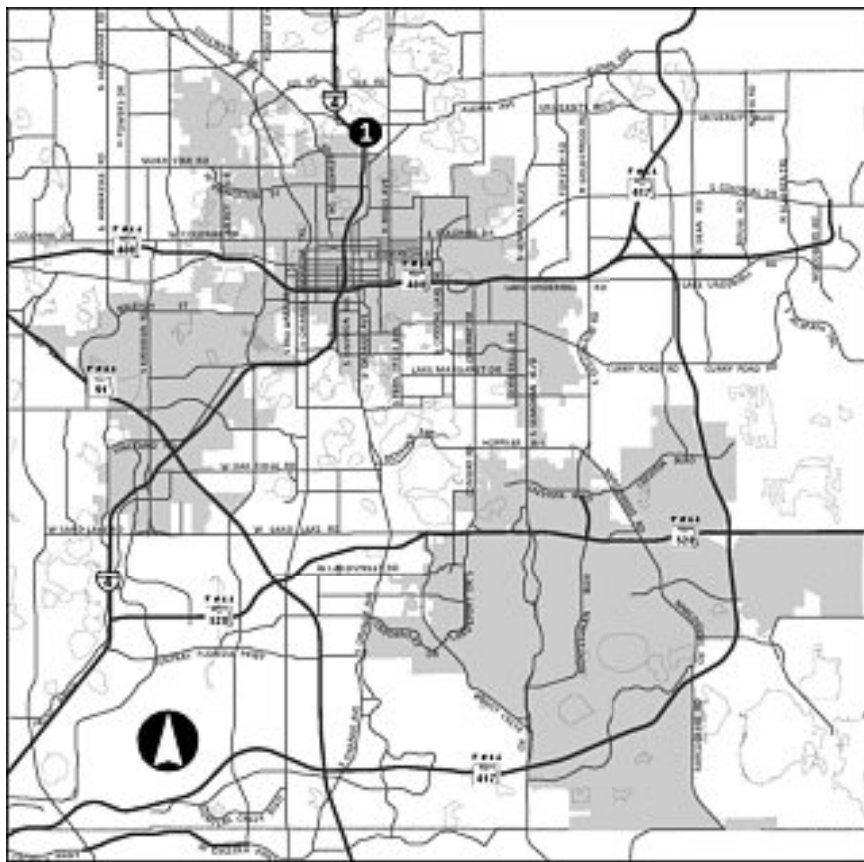
NOTICE OF LAND USE CHANGE
