#### **RECOMMENDATION:**

Selection of Visium Resources, Inc. to provide Real Estate Management Staff Augmentation Services, Request for Proposals Y20-1094-TJ. Request authority for the Procurement Division to negotiate and execute a contract within a budget of \$845,208 for a three-year term. Further request authorization for the Procurement Division to renew the contract for two additional one-year terms.

Proposals were evaluated by the Procurement Committee on November 18, 2020. Commissioner Maribel Gomez Cordero was assigned to the Procurement Committee.

#### PURPOSE:

This contract will provide Real Estate Management Staff Augmentation Services that will be used for short-term assignments, long-term projects, and staff augmentation. The services will facilitate staffing of Acquisition Agents and Title Examiners to support existing staff.

#### **DISCUSSION:**

Three proposals were received in response to this Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP. The proposals submitted by Diskriter, Inc. and Infojini, Inc. scored too low for Board consideration.
