On February 4, 2019, the Zoning Division received an Application for Street Name Petition to rename the approximate 3.4 miles of Flamingo Crossings Boulevard. The submittal satisfies all requirements of Resolution 2015-M-12. The new street name, approved by 911 Emergency Services on August 30, 2018, would be Hartzog Road, which would be an extension of the existing Hartzog Road to the south. There are a total of 13 property owners affected by the name change. The request is supported by at least 75 percent of the abutting property owners as required by the resolution.


The Board is authorized to rename streets pursuant to Section 21-2, Orange County Code.

- A scaled site plan which identifies the streets and the surrounding properties and parties affected by the change.
- If more than one property owner is affected then the applicant shall supply notarized statements from at least seventy-five percent (75%) of the affected property owners stating that they agree with (have no objection to) the proposed street name or street name change.

The Zoning Division and 911 Emergency Services will review the application and advise the applicant of the outcome. If the Street Name Petition is approved, the Zoning Division will notify all appropriate agencies.
