RESOLUTION GRANTING PETITION TO VACATE # 21-08-049

WHEREAS, pursuant to procedures adopted by the Board of County Commissioners, a petition was filed with the Board to vacate that certain portion of a 30-foot wide unopened, unimproved, and unnamed right-of-way and a portion of a 60-foot wide unopened, unimproved and unnamed right-of-way located in Horizon West in Orange County, Florida, as described in attachment.

WHEREAS, notice of a public hearing before the Board of County Commissioners on November 14, 2023, was published in the *Orlando Sentinel*, a newspaper of general circulation in Orange County, Florida, one time at least two weeks prior to the date for the hearing; and

WHEREAS, the Board finds that the vacating of the portion of a 30-foot wide unopened, unimproved, and unnamed right-of-way and a portion of a 60-foot wide unopened, unimproved and unnamed right-of-way located in Horizon West will not operate to the detriment of Orange County or the public.


