Subject: Award of Invitation for Bids Y20-738-RC, West Orange Trail
Plant Street Wooden Bridge Repair

ACTION REQUESTED:

Approval to award Invitation for Bids Y20-738-RC, West Orange Trail Plant Street Wooden Bridge Repair, to the low responsive and responsible bidder, Gregori Construction, Inc. in the total contract award amount of \$239,500.

PROCUREMENT:

This project consists of the replacement of a wooden pedestrian bridge with a 60-foot long precast concrete bridge and new asphalt trail for a total length of 210 linear feet. A temporary asphalt trail will be constructed to maintain trail traffic during the construction. The project location is on the West Orange Trail north of Plant Street in the City of Winter Garden. The project is located in District 1.

FUNDING:

Funding is available in account number 1050-062-2100-6310.

APPROVALS:

The Capital Projects and Business Development Divisions concur with this recommendation.

REMARKS:

Seven bids were received in response to the Invitation for Bids and were evaluated for responsiveness, responsibility, and price reasonableness. Carr & Collier, Inc. and Cloud 9 Services, Inc. were deemed non-responsive for failure to submit the original bid bond. The bid submitted from Gregori Construction, Inc. is considered reasonable based on comparison to the engineer's estimate. References provided were satisfactory for this type of work and Gregori Construction, Inc. has been determined to be responsible. Therefore, award is recommended to Gregori Construction, Inc.

SUBJECT: Y20-738- RC, West Orange Trail Plant Street Wooden Bridge Repair

Orange County would receive federal funding through the Florida Department of Environmental Protection for the services solicited in the Invitation to Bid. Accordingly, Orange County's M/WBE ordinance and program do not apply to this solicitation.

Orange County shall participate in the federal requirements 2 CFR 200.321 (or 45 C. F. R. 75.330 for Health and Human Services funds) to ensure small and minority-owned firms, women-owned business enterprises, and labor surplus area firms have been afforded subcontracting opportunities.

The Business Development Division evaluated the five bids to denote whether an executed and notarized "Affidavit of Compliance Requirements" form submitted with the proposal was in compliance with the federal requirements. Gregori Construction, Inc., Atlantic Civil Constructors Corporation, Valencia Construction Group, Inc., Schuller Contractors Incorporated and Boromei Construction, Inc. provided the executed and notarized federal compliance forms.
