Consideration: Request to rezone from A-2 (Farmland Rural District) to R-1AAA Restricted (Residential Urban District) in order to allow for the development of three detached single-family homes, pending lot split approval. The following restrictions are recommended for the applicant's rezoning request: 1. Development shall be limited to three (3) single-family detached dwelling units; and 2.
