Type of Hearing: To amend a Municipal Service Benefit Unit (MSBU) for maintenance of retention ponds and streetlighting.

Hearing Required by F. S.# Florida Statute Sections 125.01 (01) (q) and 197.3632. This public hearing may be scheduled any time prior to May 31, 2024. **The resolution must be approved by May 31, 2024 to be included on the November 2024 real estate tax bill.**

Advertising Requirements / Timeframe: **Publish only one (1) time and must be published at least twenty (20) days prior to the public hearing with the tentative advertisement date as Sunday, March 3, 2024.**

Notify Abutters: Special Assessments will mail public hearing notices to all of the affected property owners.

Report: The estimated cost for the amending MSBU for maintenance of retention ponds is \$78.00 per lot, per year and the estimated cost for the amending MSBU for streetlighting is \$137.00 per lot, per year. These amending MSBU's would be effective November 1, 2024.
