RECOMMENDATION:

Selection of CDM Smith, Inc. to provide Professional Construction Engineering and Inspection (CEI) and Resident Compliance Specialist Services for Shingle Creek Phase 1 Segment 2 (from S.R. 528 to Destination Parkway) Construction Project, Request for Proposals Y20-826-CH. Further, request the Board authorize negotiation and execution of a contract by the Procurement Division provided the contract does not exceed the budget of \$736,562.

The Procurement Committee evaluated the proposals on August 12, 2020. Commissioner Betsy VanderLey was assigned to the Procurement Committee.

PURPOSE:

The Consultant shall assist the County by providing project management, CEI, and compliance services for the Shingle Creek Phase 1 Segment 2 (from S.R 528) Construction Project. The project is funded by the Florida Department of Transportation (FDOT). The County will be reimbursed for the costs of services procured under the contract with federal funds through FDOT. The project is located in District 6.

The services to be performed include, but are not limited to:

- Provide CEI and support services for the Shingle Creek Phase 1 Segment 2 (from S.R. 528 to Destination Parkway) Construction Project, including, but not limited to, monitoring the construction contract compliance requirements for assigned projects in accordance with Required Contract Provisions Federal-Aid Contracts Federal Highway Administration 1273 and compliance oversight program established by FDOT.
- Perform geotechnical/material testing services as may be necessary.

DISCUSSION:

Three proposals were received in response to the Request for Proposals (RFP). The Procurement Committee evaluated the proposals in accordance with the criteria set forth in the RFP.

The proposal submitted by DRMP, Inc. was determined to be non-responsive to the terms and conditions of the solicitation for the following reason:

FDOT's Local Agency Program Manual, Section 18.3, Conflict of Interest states the following:

- A consultant firm, its affiliate that was a subconsultant to the Engineer of Record (EOR) on a project may only be considered as a prime for CEI services on the same project, with the approval of the District Secretary.
- A consultant firm, or its affiliate, that was a subconsultant to the EOR on a project may only be considered as subconsultant for CEI services with the approval of the District Secretary.
- DRMP, Inc. was a subconsultant to WBQ Design & Engineering, Inc., Contract Y12-819 Final Engineering Design for Shingle Creek Multi Use Trail. The District Secretary did not provide the aforementioned approval.

The proposal submitted by New Millennium Engineering, Inc. scored too low for Board consideration.
