You are invited to attend and be heard regarding the following proposed ordinance:

AN ORDINANCE PERTAINING TO FINES IMPOSED UPON CRIMINAL OFFENDERS IN ORANGE COUNTY, FLORIDA; AMENDING SECTION 14-8 OF THE ORANGE COUNTY CODE RELATING TO THE "CRIME PREVENTION FUND" TO CONTINUE THE ALLOCATION OF SUCH FUNDS TO THE ORANGE BLOSSOM TRAIL LOCAL GOVERNMENT NEIGHBORHOOD IMPROVEMENT DISTRICT AND THE PINE HILLS LOCAL GOVERNMENT NEIGHBORHOOD IMPROVEMENT DISTRICT FOR AN ADDITIONAL 10 YEARS; REMOVING THE REQUIREMENT THAT FUNDS NOT DISBURSED BY THE DISTRICTS BE RETURNED TO THE FUND; PROVIDING AN EFFECTIVE DATE.
