The Pine Hills Local Government Neighborhood Improvement District Advisory Council (the "Council") is composed of seven members: two nominated by the Mayor, one nominated by the District 2 Commissioner, one nominated by the District 6 Commissioner, two nominated by the Pine Hills Community Council, and one nominated by the Pine Hills Safe Neighborhood Partnership. Representatives must be property owners or residents within the boundaries of the Pine Hills Local Government Neighborhood Improvement District. The Board appoints all Council members. Terms are for three years. Attached is a list of the current members of the Council for your review.

Recently, one of the Mayor's representative, Shabana Khublal, resigned from the Council. Mayor Demings has nominated Michael P. Strayhorn to succeed Ms. Khublal as the Mayor's representative with a term expiring June 30, 2020.
