December 2018 Neighborhood Pride Sign Grant Recipients

The Neighborhood Preservation and Revitalization Office administers the Neighborhood Pride Grant Program that provides funds for citizen organizations to enhance the quality of their neighborhoods. The Neighborhood Pride Grants are available countywide in amounts ranging between \$1,500 to \$10,000. Neighborhood Pride Grant applications are accepted year-round and are reviewed monthly by the Neighborhood Grants Advisory Board (NGAB).

The NGAB is recommending the approval of sign grants for Sylvan Highland Neighborhood (\$5,000), Brandy Harbor Neighborhood (\$5,000), Chickasaw Oaks Neighborhood (\$3,500), Meadow Woods Village 7 Neighborhood (\$5,000), and Bonneville Neighborhood (\$5,000) (see Attachment A). The grant requests are displayed in greater detail in Attachments B, C, D, E, and F. The grant requests were reviewed by Orange County staff and presented to the NGAB for recommendation. The applications were reviewed based on project feasibility, organizational readiness, and benefit to the community. In addition, the applications were reviewed against the County's permitting requirements to ensure that the project would comply with appropriate County codes.

The vendors responsible for permitting the signs have been instructed that a Maintenance of Traffic Permit may be required for each sign, depending on the location. These costs may be up to \$1,000 per sign and will be added to the amount of the grant.

Finally, the organizations are required to sign a letter of agreement recognizing their responsibilities throughout the grant process, document the appropriate match, and demonstrate an ability to maintain the project.
