PROJECT: Y25-702-RC, Orange County Convention Center West Building Roof

Fan Replacement

The Business Development Division evaluated two bids submitted for this project and completed an M/WBE Availability Analysis. The scope of services for this project had limited M/WBE availability, as the user division indicated the HVAC fans and curbs had been purchased for \$3,416,991.07. As a result, the M/WBE goal was reduced from 25% to 12%. At the time of bid opening, at least 41 firms were certified available to provide the scope of services at the subcontract level.

The apparent low bid, submitted by Harper Limbach, LLC reported 23.00% of the M/WBE participation. The apparent low bid met the Orange County M/WBE participation goal **per the Ordinance requirement.** Please note the following certified M/WBE participation:

The second low bid, submitted by Poli Construction, Inc., reported 31.27% in M/WBE participation. The second low bid met the Orange County M/WBE participation goal **per the Ordinance requirement.** The bidder listed Pioneer Welding & Fabrication, Inc. as a Registered Service-Disabled Veteran company for M/WBE participation. However, M/WBE credit was not given because Pioneer Welding & Fabrication is not M/WBE certified.
