PROJECT: Y25-743-JF, OC Johns Lake Cons Area Parking Improvement

The Business Development Division evaluated the three lowest bids of nine total bids submitted for this project. The Business Development Division (BDD) completed an Minority/Women Business Enterprise (M/WBE) Availability Analysis. The analysis found that the scope of services for this project had limited M/WBE availability. As a result, the M/WBE goal was reduced to 14%. Despite the limited availability, at the time of bid opening, at least 55 firms were certified to provide services at the subcontracting level.

The apparent low bid was submitted by Orange County Certified Minority Business Enterprise, Valencia Construction Group, Inc., who is bidding as a prime. Therefore, the bidder is required to self-perform no less than 51% of the contract per Sec. 17-321 in the M/WBE Ordinance. In the event this requirement is not achieved, other M/WBE's will have to be included to achieve the 14% M/WBE goal. The bidder reported self-performing 77.77%. Therefore, the bidder met the 14% Orange County M/WBE participation goal **per the Ordinance requirement.**
